4. INTRODUCTION

4.1 SCOPE

4 watt Chip On Board (COB), 1W LED and 3 UV LED rechargeable inspection lamp, 4W COB to be used as an inspection lamp and 1 LED or 3 UV LED for use as a torch. Magnets on the base and on the rear, two 360° swivel hooks. Base pivots 180°, supplied with mains charger and 12V charger.


CONNECTION TO THE POWER SUPPLY (CHARGERS)

Make sure the power supply information on the machine's rating plate are compatible with the power supply you intend to connect it to.

This lamp comes supplied with a UK standard 3 pin transformer. It is designed for connection to a domestic power supply rated at 230V AC.

It is Class 2 (double insulated); is designed for connection to a power supply matching that detailed on the rating label and compatible with the plug fitted. If an extension lead is required, use an approved and compatible lead rated for this appliance. Follow all the instruction supplied with the extension lead. This product requires no earth connection as supplementary insulation is applied to the basic insulation to protect against electric shock in the event of failure of the basic insulation.

UNPACKING & CHECKING 7.

7.1 PACKAGING

If any of the packaging is to be thrown away, make sure they are disposed of correctly; according to local regulations.


PREPARING THE INSPECTION LAMP 8.

8.1 CHARGING - FIG.1

Connect the charging plug into the charging socket ③, which is located on the rear of inspection lamp. Connect the 230V charger or 12V DC charger to a power supply and turn it on.

The charging LED indicator (9) will illuminate red, charge for 5 hours or until the charging LED illuminates green.

Disconnect the charger from the inspection lamp when it is fully charged.



OPERATING THE INSPECTION LAMP 9.

9.1 OPERATION - FIG.2

CAUTION: Never shine the LED light directly into your or any one

's eyes.

To run through the sequence of modes (3 UV LEDs, 1 Watt LED, 4 Watt COB and off).

Press the on/off 7 button.

The lamp can be suspended and swivel 360° on hooks ① or the magnets ② and ④ located on the rear on base of the lamp.
